Thai - EU Experts' Exchange on Extended Producer Responsibility (EPR) in Packaging Tuesday 5 September 2023, 9.00 - 16.30 hrs, VIE Hotel

OBJECTIVE:

The aim of the Workshop is to promote an exchange of knowledge, experience and best practices between EU and Thai experts in support of Thailand's work towards establishing a mandatory EPR system, which is a key component in Thailand's national agenda of Bio-Circular-Green Economy. The participants include Thai experts who are involved in the drafting of an EPR law, members of Thailand's Steering Committee for Packaging Management following the EPR and Circular Economy Principles, municipalities (such as Bangkok Metropolitan Administration), as well as Thailand's international partners (GIZ, UNEP, COBSEA). It is hoped that the Workshop will be a starting point for collaboration between Thailand and our international partners especially the EU on EPR and to further promote economic development together with environmental conservation.
