






## **SWOT** Analysis

  - We are supported by the Royal Thai Embassy in Wellington, New Zealand.






#### Weaknesses:

# Thailand is 9th largest trading partner of New Zealand

New Zealand's major exports to Thailand: Milk powder and other dairy products, apples, wood pulp.

New Zealand's major imports from Thailand: motor vehicles, plastics, tyres, air conditioners and refrigerators.

#### Thailand - New Zealand Closer Economic Partnership


Tariffs and quotas on all New Zealand's exports will be fully eliminated by 2025.
Beginning on January 1, 2015, 65% of exports entered Thailand without incurring any duty.

Conversely, tariffs on over 70% of items in Thailand's exports have been eliminated to 0%. This reduction started in 2015 and has been progressively applied to all items, reducing tariffs to 0%.

#### New Opportunities

The growing renewable energy sector presents opportunities for New Zealand companies with relevant expertise in Thailand.

As the second-largest economy within ASEAN, with a large population and 'upper middle income' status, Thailand is a market with significant potential for New Zealand exporters.




